3. An annual maintenance support contract is in place
4. No decision has been taken as to whether the contracts will be extended or renewed.
5. The annual value of the contract is £9,000 Ex-VAT
6. This question is not applicable as only one contract in place.
7. The Contract was procured in accordance with Public Contract Regulations 2015 via the Tender process.

In relation to your request under question 8, the Trust does not publish contact details for its employees as they have a right to privacy in work.

The Trust is applying an exemption under Section 40(2) of the Act, this is because you have requested personal data about someone other than yourself.
