Your Request:

Under FOIA , I am requesting the following information:

*a) All e-mail correspondence (including any attachments) sent to, CC'd to or from the Haemophilia Centre Director during the period 5th April 2023 - 19th July 2023 which relates to the Infected Blood Inquiry or Infected Blood Compensation. The scope of this request excludes patient data.*

The Trust has reviewed your request which is correctly formatted and complies with Section 8 of the Freedom of Information Act.

The Information you have requested is below:

The information you have requested is not held. In ascertaining whether the information is held by the Trust or not, the Trust has interpreted your search parameter of Haemophilia Centre Director to mean the Clinical Director of the Haemophilia Centre in Cardiff, this is because a generic NHS Email address for the Haemophilia Centre Director does not exist.

A search to or from the Haemophilia Centre in Cardiff for the period 5th April 2023 to 19th July 2023 in relation to the Infected Blood Inquiry or Infected Blood Compensation has not returned any positive results.

I trust this answers your request for information, however, should you not be satisfied with the information supplied or the process of supplying it, you have a right to complain and request a review. Please note that you must submit a request for a review within 40 days of the date of this letter.
