Thank you for your request for information which the Trust received on 8th November 2023.

We apologise for the delay in responding.

Your Request:

I would like information on any costs incurred (if any) by VUNHST through outsourcing its services to independent care providers (such as Radiotherapy).

Please find the Trust's response below:

The Trust does not record the data requested in a format that enables the information to be easily retrieved to the level of detail required to specifically answer your request.

In reaching this decision we estimate that it would take a minimum of 40 hours or £1000 an amount of £550 over the core amount of £450 extra to obtain the data. The amount would require payment in full prior to the Trust undertaking the work.

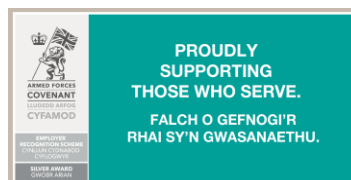
As result, the Trust is applying a Qualified Exemption under Section 12 (Exemption where cost of compliance exceeds appropriate limit), the legislation in this instance states:

12 Exemption where cost of compliance exceeds appropriate limit.

(1) Section 1(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.

The Trust has a duty to advise and assist you under Section 16 of the Act and therefore may I suggest that you consider the option to revise your request so that it falls below the prescribed appropriate limit.
