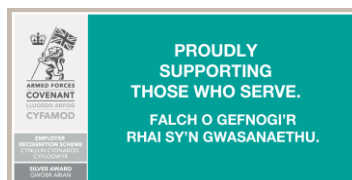

The frameworks used are RM6278, RM6277, RM6161, RM6288, however there may be others utilised under the frameworks pending the needs of the role and a case being completed.

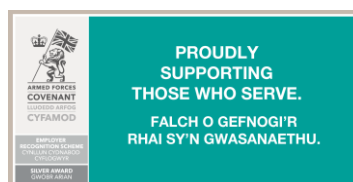
