Your Request:

Q1. *How many patients were treated for Urothelial cancer (any stage) in the past 3 months with the following treatments:*

- *Atezolizumab (Tecentriq)*
- *Avelumab (Bavencio)*
- *Carboplatin single agent or in any other combination*
- *Carboplatin with Gemcitabine*
- *Carboplatin with Paclitaxel*
- *Cisplatin single agent or in any other combination*
- *Cisplatin with Gemcitabine*
- *Nivolumab (Opdivo)*
- *Pembrolizumab (Keytruda)*
- *Other active systemic anti-cancer therapy*
- *Palliative care only*

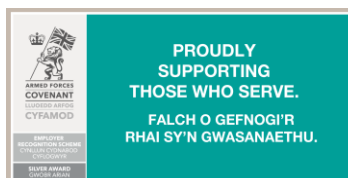
Please find the Trust’s response below:

There have been <6 patients treated with the above regimens during the 3-month period of December to February 2024. Please note this is the number of unique patients treated with the above, as such some of these patients may have received more than one of these drugs/treatments.

Where the figure provided is less than 6, and where simple calculations could identify fields that contain less than 6, the Trust has applied an exemption under Section 40(2) (personal data) of the Freedom of Information Act 2000. This is because the Trust believes there is a potential risk of individuals being able to be identified if the figures were disclosed.

I trust this answers your request for information, however, should you not be satisfied with the information supplied or the process of supplying it, you have a right to complain and request a review. Please note that you must submit a request for a review within 40 days of the date of this letter.
