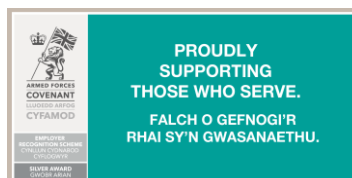

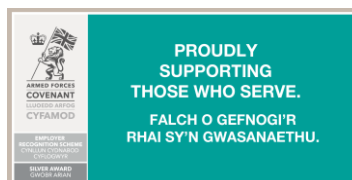
There has been no sale of any WBS/Trust vehicle assets in the period specified.

We are withholding the vehicle registrations under Sections 31(1)(a), Section 38(1)(b) and Section 40 of the Freedom of Information Act.

- Section 31(1)(a) - the prevention or detection of a crime. We believe disclosure would, or would be likely, to allow the possibility of cloning the vehicles registration number.
- Section 38(1)(b) – health and safety – would or would be likely to endanger the health and safety of an individual.
- Section 40(2)(a) – could be considered personal data where the car is designated to an individual.

I trust this answers your request for information, however, should you not be satisfied with the information supplied or the process of supplying it, you have a right to complain and request a review. Please note that you must submit a request for a review within 40 days of the date of this letter.
