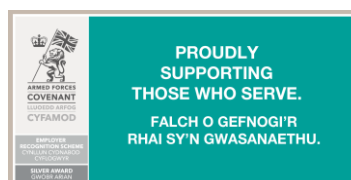

The Trust is applying an exemption under Section 14(2) of the Freedom of Information Act 2000:

Section 14(2) - Vexatious or repeated requests:

- (2) Where a public authority has previously complied with a request for information which was made by any person, it is not obliged to comply with a subsequent identical or substantially similar request from that person unless a reasonable interval has elapsed between compliance with the previous request and the making of the current request.

The application of this exemption is because a reasonable interval has not elapsed since the last time identical information was provided to you. We receive this request approximately every three months and have confirmed that most of it is not relevant to the Trust as we do not use Agency for Nursing.

The Trust suggests that you may wish to revise your periodicity of requests so that a reasonable interval has elapsed to enable the Trust to provide information to you whilst be mindful of its resources in providing such information. In addition, please revise your request to questions relevant to the Trust.

I trust this answers your request for information, however, should you not be satisfied with the information supplied or the process of supplying it, you have a right to complain and request a review. Please note that you must submit a request for a review within 40 days of the date of this letter.

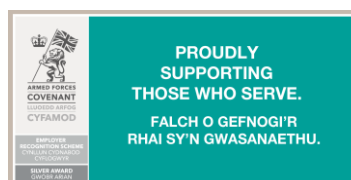
