The Acorn consortium is not a legal entity and was a bidding consortium for the nVCC contract. The Trust has awarded a contract to Acorn Velindre Limited which is a registered company number 14526572. Details are publicly available on the Companies House website.

The Trust has a contract (Project Agreement) with Acorn Velindre Limited for the Design, Construction, Financing and Maintain the nVCC.

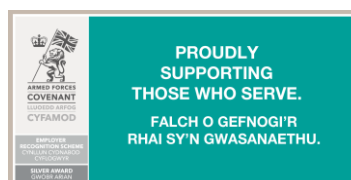
It is Acorn Velindre Limited who then enters into contracts to deliver what they need to deliver their contract with the Trust. We therefore do not have access to their contracting information.
