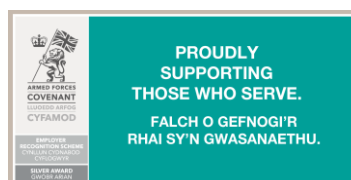
Due to the nature of the services provided by the Trust, as explained below, we do not hold information relating to your request.
