The position was created in November 2021.

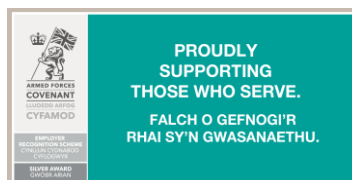
2. The start and end dates of each individual's employment in this specific post.
