3. *The current waiting times for patients to have an ambulatory ECG monitor fitted at each hospital.*
4. *The number of patients currently on the waiting list for ambulatory ECG monitoring at each hospital.*
5. *The number of ambulatory ECG recordings awaiting analysis at each hospital.*
6. *The current wait time for an ECG recording to be analysed once the patient has returned the monitor at each hospital.*
7. *The target timeframe within which each hospital aims to analyse routine ECG recordings after the monitor is returned.*

Please find the Trust's response below:

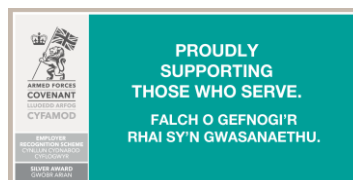
Ambulatory ECG monitoring is not a service delivered by Velindre University NHS Trust. The patient's local health board would host this service.
