Thank you for your request for information which the Trust received on 4th March 2025.

Your Request:

- 2) *Could you also let me know the total cost of employing these roles?*
- 3) *Could you let me know the number of Equality, Diversity and Inclusion roles, and the associated costs please?*

Please find the Trust's response below:

- 1) **Can you please let me know the number of senior project managers, project managers, senior project support officers, project officers, project support assistants employed?**

There are 50 substantive staff with "Project" in their job title.

- 2) **Could you also let me know the total cost of employing these roles?**

The total actual salary for the 50 staff in question 1 is £2,225,901.00

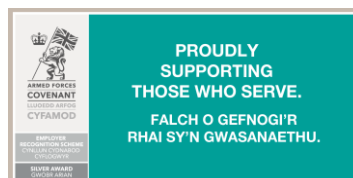
- 3) **Could you let me know the number of Equality, Diversity and Inclusion roles, and the associated costs please?**

The Trust has less than 6 members of staff hired in a DEI role with a cost of £49,254.

Where the figure provided is less than 6, and where simple calculations could identify fields that contain less than 6, the Trust has applied an exemption under Section 40(2) (personal data) of the Freedom of Information Act 2000. This is because the Trust believes there is a potential risk of individuals being able to be identified if the figures were disclosed.

I trust this answers your request for information, however, should you not be satisfied with the information supplied or the process of supplying it, you have a right to complain and request a review. Please note that you must submit a request for a review within 40 days of the date of this letter.
