Please find the Trust's response below:

The Trust considers the documents commercially sensitive as a whole and is utilising an exemption under Section 43(2) of the Freedom of Information Act 2000, as per our previous response.

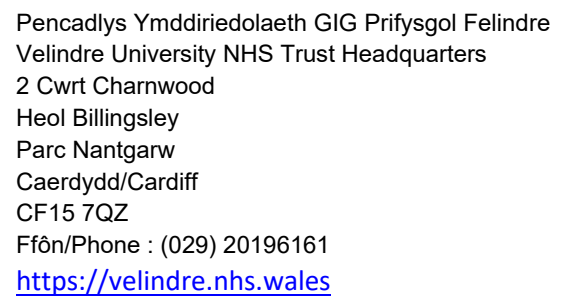
Additionally, the Trust considers that attempting to redact the documents would leave little to no information and, due to the scope of the documents, would create a disproportionate burden on Trust resources (Section 14(1)). The Project Agreement alone is over 1300 pages.

Although we appreciate there is likely serious purpose and value in your request, we must consider whether the impact on the Trust is justified. Whilst we do not believe your request was intended to be oppressive, the Trust cannot reasonably comply with its obligations under Section 1(1) of the Freedom of Information Act without incurring significant encumbrance and impact on its day-to-day activities.

I trust this answers your request for information, however, should you not be satisfied with the information supplied or the process of supplying it, you have a right to complain and request a review. Please note that you must submit a request for a review within 40 days of the date of this letter.
