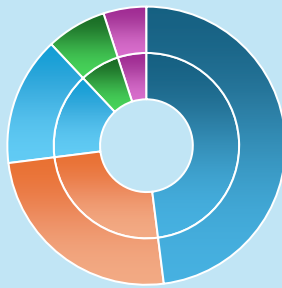
Staff news

We said goodbye to Bernadette Coles who retired as Velindre’s librarian after 34 years! Bernadette developed extensive expertise over the years in evidence-based medicine and played a key role in the production of systematic reviews both with staff at Velindre and as an Information Specialist for the Cochrane Collaboration. The advanced literature searching skills she developed also supported patient care, service improvement and research providing up to date information for all levels of staff.



Following Bernadette’s retirement Anne Cleves was appointed as the new Velindre Librarian. We also welcomed Hannah Davies to Velindre as the new Assistant Librarian.

We carried out **88** evidence searches and supported **9** Systematic Review Projects. In addition, we ran **3** systematic review updates and supported other library professionals by peer reviewing several search strategies, including strategies for the Cochrane Collaboration.

We spent over 572 hours on this activity – that’s nearly 81 working days!

Library Usage

Footfall: (during staffed hours): there were 1933 visits to the library over this period.

Document supply: we sourced 436 interlibrary loans.

Supplied 1129 articles from our own Velindre e-journals.
